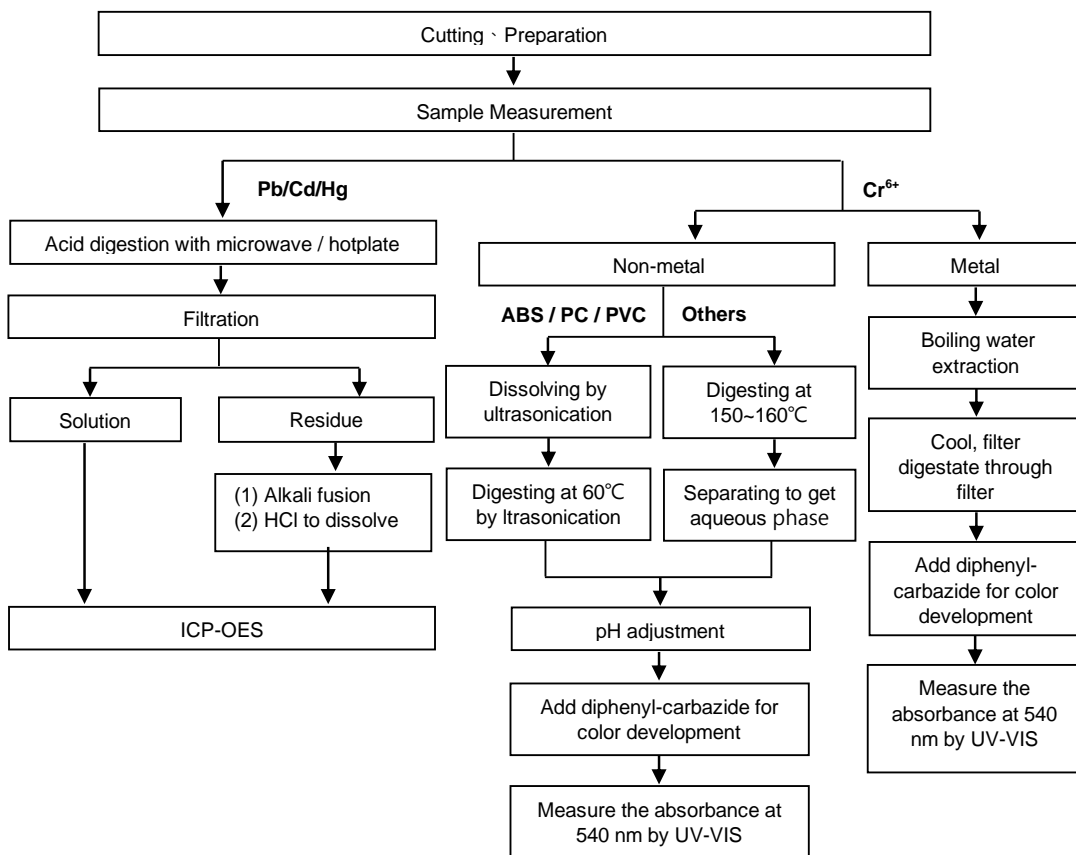

### Analytical flow chart of Heavy Metal

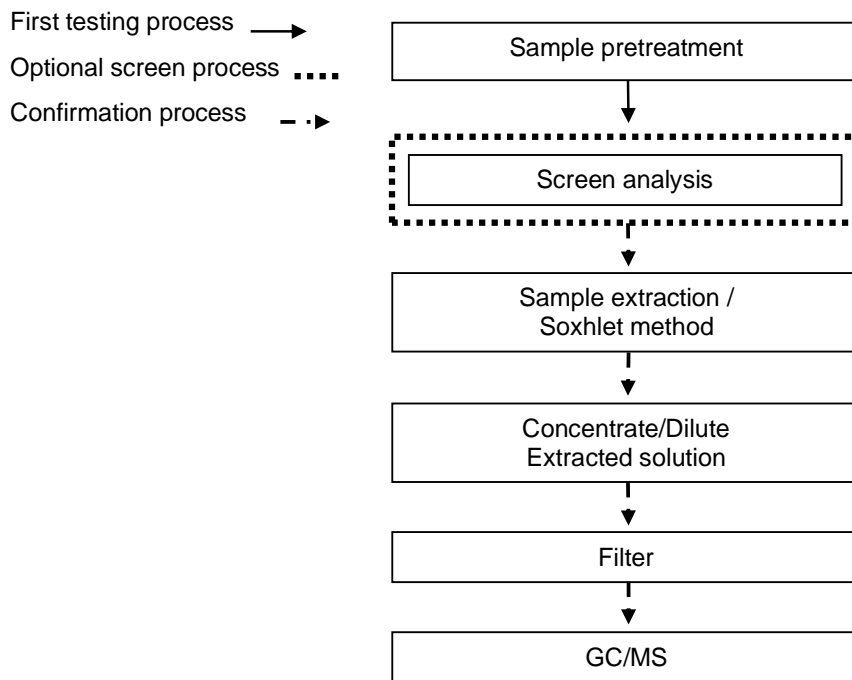

### Analytical flow chart – PBBs / PBDEs

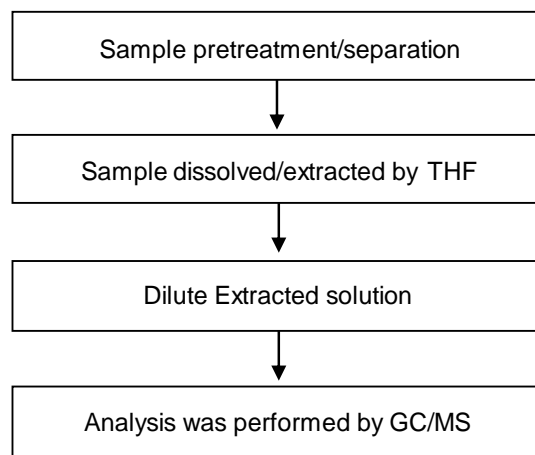

### Analytical flow chart - Phthalate

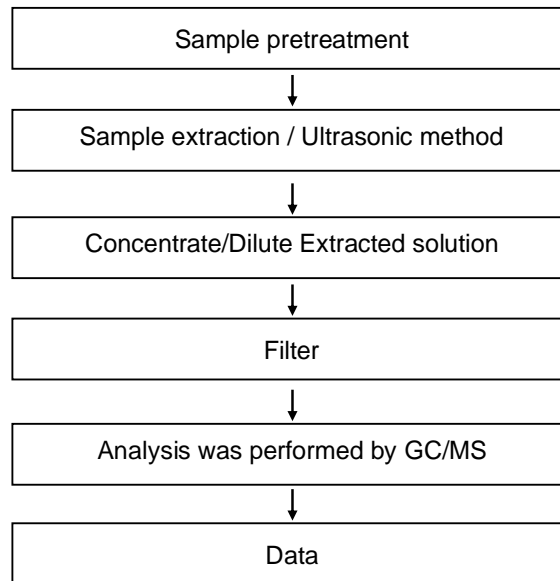

### Analytical flow chart - HBCDD



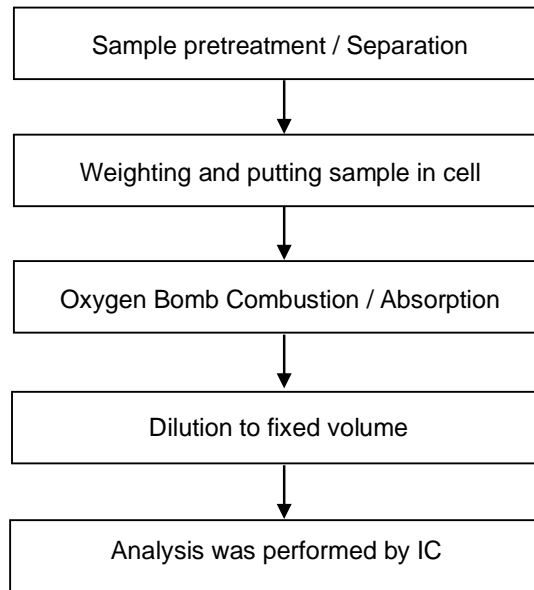

### Analytical flow chart - Halogen

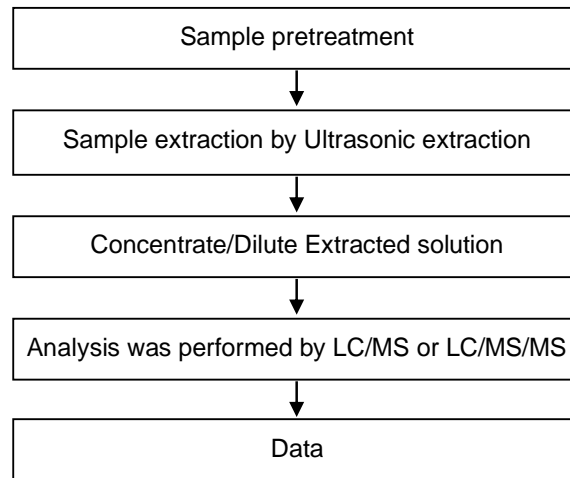

### Analytical flow chart - PFOA/PFOS

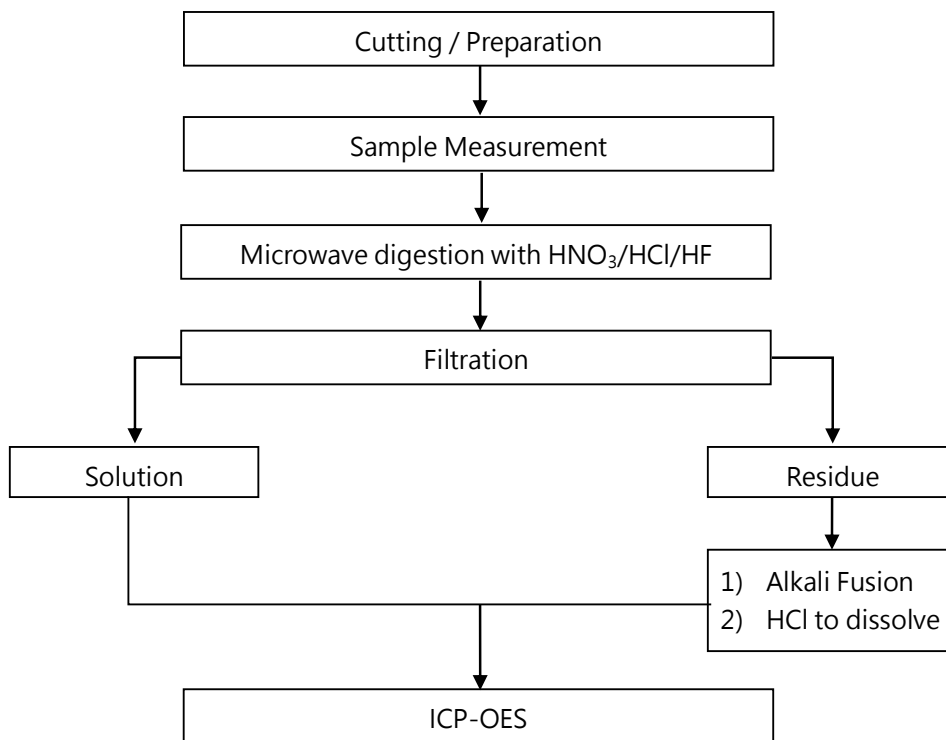
